Hi Richard,

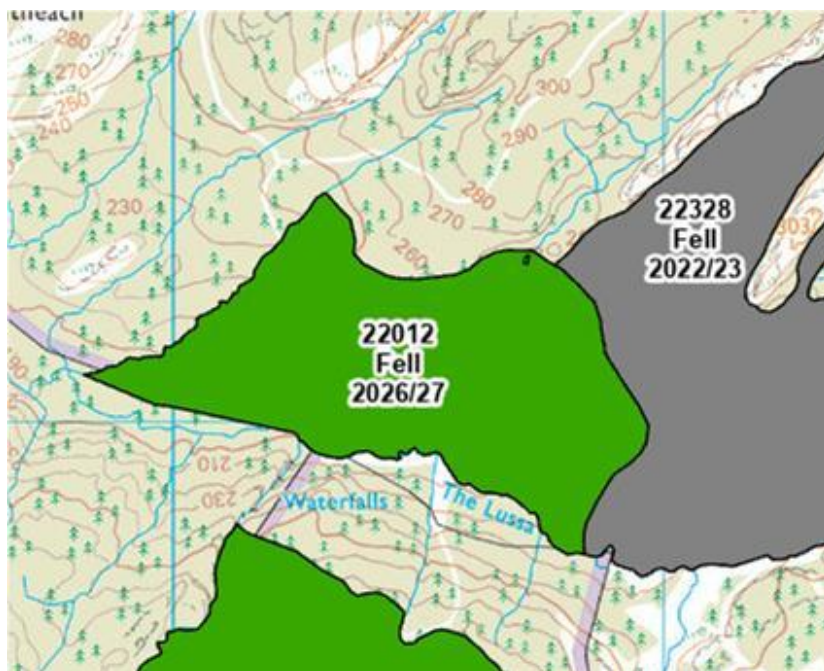
Things are getting quieter now as we reach our timber haulage limitations for Knapdale.

Faery Isles you have seen the traffic management at roadside - drawing to a seasonal close. We have more to do around this site around Loch Coille Bharr but will wait for the summer to pass before resuming Lochside.

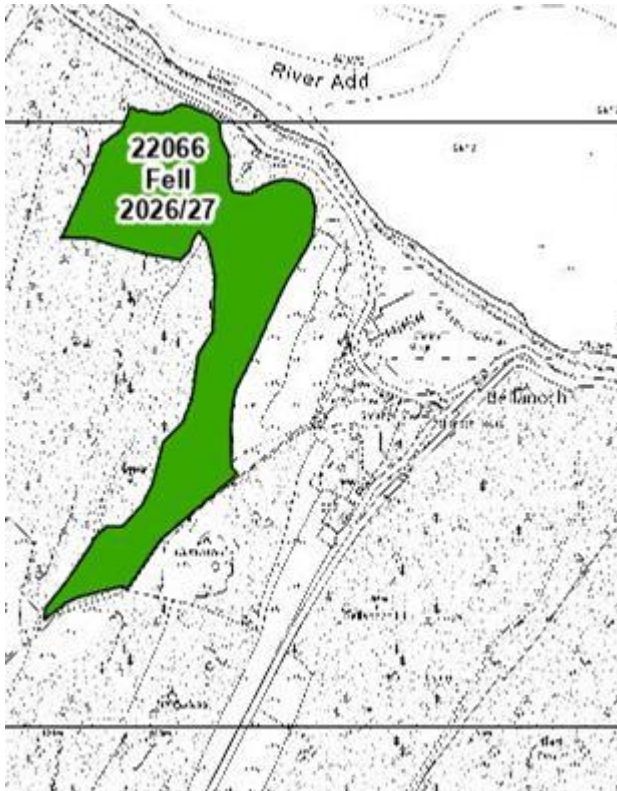
Scotnish is time dependant so keen to start working soon

And we have a coupe planned at the back of Bellanoch which we previously talked about the maintenance of the power line.



We do have plans for two of the coupes next to the haul road at Ach nabreac which is not in your area but may well affect the community due to the proximity. This is not influenced by Knapdale haulage limitations.

Works continue around Barnluasgan which has limited walks around the Lochan. I'm hoping to have it signed back in around three weeks.

The new parking meters have been received well from visitors. The less confusing method of payment seems to be well received.

I'm expecting large numbers of camper vans to the area as geopolitics and oil prices continues to influence holiday decisions. Early into the season it looks as though this is the case. We will continue to encourage campers into Ach nabreac which seems to be working well. If there is any feedback from the community regarding camper affects then I would be keen to hear them.
